

Extract from a statement about the recent bad press

I was present at the tribunal which led to Dr Blacker (“Alan”) being deprived of his benefits and his conviction in the court and on both occasions I felt the entire proceedings were personal as he had won over three hundred cases for veterans and the department he faced daily knew all about his work as a volunteer and he was not assisted by a barrister who did the perfunctory job of representing him and nothing more; subsequently and after three appeals he has had his benefits backdated to the trial and reinstated at higher rates than before thus vindicating him and albeit now out of time, overturning his conviction.

The conceited conniving conspiring bastards all knew. And none has paid for it. I have been destroyed professionally by lies and deceptions and by useless counsel, the SRA and BSB who knew. I was sexually abused by Smith, Rowen, Forbes and Needham over nine years and that's why I was persecuted prosecuted convicted and defamed. And if you believe and support that activity you are aligning yourself with them."

Alan has impeccable good character as far as I am concerned, the conviction is long since spent, and the striking off was a farce and again personal, his bona fides and accounts are verified by experts and he has shown me original certificates with holograms and numbers which have been easy to verify and check with the bodies concerned.

I can also confirm that Alan's bona fides and qualifications were subject to defamation proceedings run by a barrister from Goldsmith Chambers where they capitulated and settled out of court for a substantial sum and had to retract the allegations published in the press.
